Footnotes

GHOSTWALKING moved out nearing the first turn, raced four wide on that turn, settled on the outside, moved closer with a half-mile to run, vied four wide on the far turn, came under a drive in upper stretch, was bumped outside the eighth-pole, gained the lead entering the final furlong and proved best under steady urging. SUMO set the clear pace while off the rail, was asked near the quarter-pole, drifted out and bumped GHOSTWALKING outside the eighth-pole, lost the lead entering the final furlong and was outfinished while able to get the place. KARAMA went three wide on the first turn, was reserved off the pace, moved closer while off the rail on the far turn, shifted four wide near the five-sixteenths pole, was asked at the quarter-pole, came under a drive in upper stretch and finished willingly for the show. HARMONIZER went two then three wide on the first turn, settled outside on the backstretch, was urged along while three then four wide on the far turn, came five wide into the stretch and failed to rally. QUICK DELIVERY settled on the inside, saved ground through the far turn, came under a drive in upper stretch and failed to threaten. FACE THE FIRE raced three wide on the first turn, settled in second position, moved closer with a half-mile to run, came under urging while three wide on the far turn, chased into the stretch and had nothing left. STAND was asked from the start then reserved while off the rail, came under urging while two then three wide on the far turn, came four wide into the stretch and was no factor.
