MOONBIE set the pace while in hand, controlled the tempo while near the inside on the turn, responded well when asked at the top of the stretch, extended the advantage under urging and drew away under steady handling. APPEALING IMAGE was well placed just off the pace on the inside, came under urging near the five-sixteenths pole, moved out in upper stretch and earned the place while no match for the winner. GONNA TELL MAMA broke outward at the start, stalked the leader on the outside, chased two to three wide on the turn and weakened while able to get the show. PULGARCITO settled off the pace, raced off the rail on the turn, was asked nearing the five-sixteenths pole and failed to respond. DIVA'S DUKE was carried out at the start, settled on the outside, was urged along while three wide on the turn and came up empty.
