OH SAY VICKI forward along the inside early, eased back off the leaders down the backstretch, moved out a bit before the drive, bid three wide turning for home, took over before mid stretch and lasted. ADOPTED DAUGHTER reserved along the inside early, eased out midway around the turn, rallied mid track and was too late. JOYCE ANN devoid speed, rallied five wide but did not have enough late. READ ME MY RIGHTS dueled for the lead, was displaced nearing the furlong marker and faded along the rail. RUN SARAH RUN never far back, had no rally. MISS BRIDGET JONES trailed until the drive and was no threat. SPRING RUSH prompted the pace three wide early and faltered once reaching mid stretch. MISS MARY APPLES vied for the lead between foes until the turn and gave way.
