FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. Free nomination by Saturday, February 2. \$400 to enter, \$400 additional to start. Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$75,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to starters sixth through ninth. Weight 122 lbs. Non-winners of \$45,000 since December 12, allowed 2 lbs. \$25,000 since November 12, allowed 4 lbs. \$20,000 since then allowed 6 lbs. (Maiden, claiming and starter races not considered in estimating allowances). Starters to be named through the entry box by the usual time of closing. The Mardi Gras Stakes will be limited to fourteen (14) starters. High weights will be preferred. Failure to draw into the race will cancel all fees. A trophy will be presented to the winning owner. Closed Saturday, February 2, 2013, with 11 nominations.

Footnotes

GOOD DEED contested the early lead on the outside, moved clear outside the half-mile pole, controlled the action while three then two wide on the turn, responded well asked near the three-sixteenths pole and held under steady urging. BEAT THE BLUES broke a bit slow then brushed with IRE, settled in third position, went two then three wide on the turn, shifted four wide into the stretch, pursued the winner under a drive and finished well to just get the place. IRE broke out and brushed with BEAT THE BLUES, steadied off heels early, settled at the rear, saved ground while urged along on the turn, came under the whip in upper stretch and finished with good energy to just miss the place. MONONO disputed the early lead then chased the winner, went four then three wide on the turn, came under the whip in upper stretch and tired. MY MY MY MARIA settled off the pace, went two then three wide on the turn, swung five wide into the stretch and lacked the needed response. FLASHY LASSIE was urged along on the outside, went three to four wide on the turn and came up empty.
