Footnotes

SEAINSKY allowed to settle, moved up outside RACE ON GREEN once reaching the backstretch, angled in to take over and get clear, responded when collared and proved best under steady pressure. BRIGHT VALOUR forwardly placed inside, eased out to move up quickly to bid outside SEAINSKY before the second turn, dueled with that one thereafter but was not good enough. NOTICION (ARG) raced inside until the drive, was switched outside, closed gamely but was too late. FIFTY STARS allowed to settle, was no real threat. ACT OF WAR was outrun. RACE ON GREEN got clear early, steadied when SEAINSKY angled in and to the lead, gave way. A CLAIM OF FOUL BY THE RIDER OF RACE ON GREEN AGAINST THE WINNER FOR ALLEGED INTERFERENCE WAS NOT ALLOWED.
