BEAUTIFUL AFFAIR was ridden along in the front half of the field, saved ground on the turn, rallied inside in upper stretch, made a bid entering the final furlong and drew clear under good handling. SHE'SABREES was urged along towards the rear, raced inside on the turn and finished with good energy to garner the place. SUCCESSFULPRINCESS set the clear pace, controlled the action while off the rail on the turn, was asked for her best in upper stretch, lost the lead inside the furlong marker and weakened then was caught for the place. LADY SPENCER was ridden along while off the pace, raced three wide on the turn and finished willingly to just miss the minor awards. MEREDITH'S REBEL was urged along while off the pace, raced two then three wide on the turn, came four wide into the stretch, was put to a hard drive and lacked the needed response. TRANS CONTINENTAL was ridden along on the outside, raced four wide on the turn, came five wide into the stretch and failed to menace. MY DIXIE DOODLE raced well back in the field while off the rail and failed to threaten. INTERCOMPANY LOAN was urged along towards the front, raced between rivals on the turn and weakened. ALEGRA was ridden along in the

middle of the field, raced three then four wide on the turn and failed to rally. NETTIE HUGHES was beaten for speed, moved out while at the back, went three then two wide on the turn and was no factor.
