COMALAGOLD forwardly placed off the leaders, moved to the rail approaching the drive, angled out nearing mid stretch, closed determinedly and got up late. HUMMEL broke alertly, sprinted clear and to the inside down the backstretch to set the pace, remained clear for the drive and was caught late. FULL TIME DANCER reserved along the inside, was asked midway around the turn, was steered out in the lane and closed a late gap. NATIONAL PASTIME bumped by DACTIQUE'S QUEST at the break, recovered, showed late interest. DACTIQUE'S QUEST veered in at the break bumping NATIONAL PASTIME, was unhurried down the backstretch and lacked the needed finish. CRAFTY TAYLOR showed speed until the drive and faltered. BOONE'S DIAMOND was always back.
