MY HAPPINESS (ARG) unhurried early, rallied around the second turn, rallied outside for the drive, surged clear and proved best while kept to the task. HIDDEN GLANCE devoid speed, came for wide around the third turn and got up for second. ANTRIM COUNTY close up, set the pace off the rail until before mid stretch, was headed and held on well. CAJUN PRIZE held the early lead, was displaced by ANTRIM COUNTY before a half, maintained a forward position but had no late kick. SWAINS NEWS never far back, had no response. RED ROCK CREEK was no real threat. EVADE forwardly placed off the rail to the third turn, faded. DR. ALEX raced inside to no avail. SHIFT IN POWER showed speed to the third turn, then stopped.
