MISS GOLDWIN veered in at the break, was hustled up from the inside to move clear midway down the backstretch, remained clear for the drive, got headed in mid stretch, drifted out bumping PRINCESS FORTY ONE inside the final sixteenth, then drifted out again but held on. PRINCESS FORTY ONE close up from early on, ranged up outside MISS GOLDWIN approaching mid stretch, gained the edge just after, drifted a bit, then was bumped and carried out by MISS GOLDWIN a sixteenth out, then continued to drift while outfinished. YARE forwardly placed, loomed in upper stretch, then while no match for the top two was game for the show. SILK STREAM out footed early, moved to the inside around the turn, continued inside in the lane and was outfinished. DEEPGREENSANDBLUES devoid speed, improved position. OBJECTIONSUSTAINED raced inside to no avail. ANNOUNCE ADEAU showed little. LIVEALITTLEBIT showed early foot, then weakened. FOLLOWING A STEWARDS INQUIRY, MISS GOLDWIN WAS DISQUALIFIED FROM FIRST AND PLACED SECOND FOR CAUSING INTERFERENCE INSIDE THE FINAL SIXTEENTH.
