STAN MICHAEL L within striking distance, bid three wide around the turn, gained the edge, then held on. DEMI CHUE CRISIS unhurried, rallied outside and could not get up. PEACHIE KING never far back, ranged up outside STAN MICHAEL L and was outfinished. APPEALING PROSPECT devoid speed, closed mildly. SPRUCE'S SPIRIT well back, passed beaten foes. CEE BAILEY ZOOM vied to the drive, then faltered. J R CRUISER was no real threat. HE'S A SLEWVESCENT forwardly placed to the drive, weakened. BOSTON MYSTERY showed little. PETEADORIS settled off the rail, moved up before the drive, then flattened out. MERRIMANISTA dropped back steadily and was distanced.
