No Nomination Fee. \$325 to pass the entry box; \$350 additional to start. sSupplemental nominations of \$1,000 will be accepted at time of entry which shall include all fees. \$60,000 Guaranteed of which 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. Weight: 122 lbs. Non-winners of a sweepstakes at a mile or over on the turf in 2008-2009, allowed 2 lbs.; Two races at a mile or over on the turf other than maiden or claiming, allowed 4 lbs.; One such race, allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. This Stake will be limited to 14 starters should race not be split. Failure to draw into the race will cancel all fees. THE OWNER OF THE WINNER TO RECEIVE A TROPHY. Closed Saturday, February 14, 2009, with 15 nominations. MILWAUKEE MIRACLE settled inside from early on, continued inside until nearing the drive, was steered to the outside entering the drive, rallied determinedly and proved clearly best. SMOOTHCIDEUP forwardly placed off the rail, moved up three wide around the second turn, took over before mid stretch and then saved second. HEAR NO ANGEL devoid speed, split foes around the second turn, loomed a furlong out, then did not have enough late. REW'S BLUES reserved early, raced along the rail around the second turn, got steered out in the drive, then angled in inside the final furlong and was outfinished. SILENT PIPE stalked the leaders, dropped back nearing the drive, then came again. BREAK UP inside to the drive, angled out turning for home, then could make little impact. DABBERS CHIEF unhurried early, was no real threat. SHOCKIN BLOW close up to nearing the drive, gave way. LEE CITY SLEW set the pace to the drive, then stopped.
