### Footnotes

BRAVER was urged along while off the pace, saved ground on the turn, moved out in upper stretch, rallied into the final furlong, closed well to get the lead near the sixteenth-pole then moved clear under good handling. SWAN PARADISE chased the pace, came three wide into the stretch, lugged in near the three-sixteenths pole, made a bid entering the final sixteenth but was outfinished while clear for the place. BELLA DAMA brushed with a rival at the start, was ridden along towards the rear, raced near the inside on the turn, came out at the quarter-pole and got up for the show. BARI'S PULPETTE was urged along while off the pace, raced towards the inside on the turn, bumped with KLUKI in upper stretch and lacked the needed kick. BOUND N DETERMINED bumped with rivals at the start then was in tight, raced well back in the field and improved position. WILLA'S TRIBUTE was urged along on the outside,

raced three then four wide on the turn and lacked the needed response. DE RASCAL set the clear pace, extended the advantage on the turn, was put to the whip in upper stretch, remained clear into the final furlong but tired and was overtaken. FIVE TIMES was urged along on the outside, raced two to three wide on the turn and failed to rally. PURE ELLOQUENCE bumped with a rival at the start, raced well back in the field, shifted out leaving the backstretch, raced three wide on the turn and was no factor. KLUKI chased the pace, bumped with BARI'S PULPETTE in upper stretch and gave way. DEAR MARIA broke in and bumped with a rival then was taken up some, raced well back in the field and faltered. (Rail at 15 Feet)
