WATCH PAT was urged along while just off the pace, ranged up while four wide on the turn, made a bid in upper stretch, battled with the leading duo into the final sixteenth then inched clear under left hand urging late. ORPHAN BRIGADE showed good speed and set the pace, vied off the rail on the turn, was asked for his best in upper stretch, battled into the final furlong and was outfinished late but gamely earned the place. ROCKGLEN chased the leader on the outside, engaged that rival while three wide on the turn, battled into the final sixteenth and was also outfinished but just missed the place. SET IN STONE settled in the middle of the field, saved ground on the turn, was roused at the top of the stretch, moved out near the three-sixteenths pole and failed to rally. APPOINT VICTORY settled on the outside, was urged along while four wide on the turn and also failed to rally. SINISTER raced well back in the field, went three then four wide on the turn, came five wide into the stretch and failed to threaten. STRAIGHT SHOOTER lacked speed while ridden along, came off the

rail on the turn and was no factor. SAVIANO was ridden along while off the pace, shifted out leaving the backstretch, raced five wide early on the turn, dropped to three wide near the five-sixteenths pole and failed to respond. BLUE TWISTER was ridden along while off the pace, dropped back near the half-mile pole, raced off the rail on the turn and also failed to respond. ANTE GO GO was urged along while just off the pace, raced two to three wide on the turn and came up empty. MO COLD was ridden along towards the rear and showed little.
