SEE ME PROUD raced three to four wide on the first turn, settled off the pace, advanced five wide on the far turn, came seven wide into the stretch, stormed to the front and drew away while ridden out. TAKE HEART settled off the pace, moved closer on the far turn, swung seven wide into the stretch and safely secured the place. AT THE PULPIT went three then two wide on the first turn, settled off the pace, moved closer while off the rail on the far turn, was put to a drive in upper stretch and lacked the needed response while best of the rest. PAROLED went four to five wide on the first turn, settled off the pace, went three wide on the far turn, swung eight wide into the stretch and also lacked the needed response. DOC HEATH went five then four wide on the first turn, settled on the outside, advanced four wide on the far turn, came six wide into the stretch and weakened. AWESOME'S ELEVEN was well placed just off the pace, raced inside while under some urging on the far turn and came up empty. RIDINGFORTHEBRAND was fractious in the gate, went four then three wide on the first turn, settled towards the front, chased three wide on the far turn, floated five wide into the stretch, swerved in and bumped with MYSTIC LEGEND near the three-sixteenths pole and gave way. VPERYOD SERYOGA settled towards the rear, dropped to the inside nearing the quarter-pole, was in tight against the rail outside the furlong marker and also lacked the needed response. BAD RONNIE lingered well back in the field, went four wide on the far turn, came nine wide into the stretch and failed to rally. MYSTIC LEGEND raced three to four wide on the first turn, prompted the pace on the outside, came three wide into the stretch, was bumped by RIDINGFORTHEBRAND near the three-sixteenths pole then capitulated. BAREFOOT BANDIT came in after the start, lingered well back in the field, went three wide on the far turn and failed to threaten. KAYOU came in after the start, set the pace, vied into upper stretch then also gave way. FAST WOLF ducked in after the start, dropped well behind and showed little. Following a stewards' inquiry, RIDINGFORTHEBRAND was disqualified from seventh and placed tenth for interference in upper stretch. (Rail at 0 Feet)
