**Footnotes**

DEPUTIFORMER settled on the inside, moved closer with a half-mile to run, was roused while continuing to save ground on the far turn, came off the rail at the quarter-pole, rallied to the lead in upper stretch and drew away under steady urging. BLACK WING was fractious in the gate, popped open his stall door prior to the start, went three then two wide on the first turn, was reserved off the pace, raced off the rail on the far turn, drafted behind a trio of rivals late on that bend, was asked at the quarter-pole, came under a vigorous drive in upper stretch and narrowly earned the place. GROVE PARK set the pace on the inside through tepid fractions, was asked after turning into the stretch, lost the lead passing the three-sixteenths pole and proved no match for the winner then lost the place at the wire. MUSICSTREET MENACE broke through the gate prior to the start, was unhurried at the back while on the inside, saved ground through the far turn, gained ground under a drive in upper stretch and finished willingly but missed the trifecta. HORNED FROG went four wide on the first turn, settled nicely on the outside, went four wide on the far turn, bumped lightly with CUSABO while five wide into the stretch, bumped soundly with that rival near the three-sixteenths pole and failed to rally. WAJIR ON ME lagged at the rear of the field, was urged along while off the rail on the far turn, shifted three wide at the quarter-pole, moved out in upper stretch, shifted further out near the furlong marker and failed to threaten. LEAD THE WAY went three wide on the first turn, settled towards the rear, was ridden along on the far turn, angled out in upper stretch and was no factor. KELLY'SPREMONITION was bumped at the start, went five wide on the first turn, settled on the outside, was urged along while three wide on the far turn,

shifted five wide into the stretch and failed to respond. CUSABO broke in and bumped with KELLY'SPREMONITION, raced three wide on the first turn, prompted the pace, dropped back nearing the half-mile pole, went three wide on the far turn, bumped lightly with HORNED FROG while four wide into the stretch, bumped soundly with that rival near the three-sixteenths pole and came up empty. NICKEL PICKLE was a bit rank into the first turn, went two to three wide on that bend, floated five wide onto the backstretch, dragged his way closer coming to the five-eighths pole, disputed the pace on the outside, vied two to three wide on the far turn and faded.
