DIABLO'S HEALER clear early, responded when collared, drifted out entering the drive, prevailed after a long hard drive. KNOWN STAR moved up quickly from between foes to collar the leader, dueled around the turn, was fanned out entering the drive and could not get past after a long hard drive. FIERY DUCHESS raced close up from early on and lasted for third. SHAMPOO CAPE close up from the rail, dropped back a bit around the turn and then showed late interest. SMILE N' EMILY raced forward while four wide and had no rally. TOOMANYTUTUS was outrun. SILVER SLEET had no speed and was not a threat. SWEET LILLIAN saved ground. KAYLIE MARIE swerved out at the break, raced five wide early and gave way. DIVINE EVIL trailed. A claim of foul by the rider of KNOWN STAR against DIABLO'S HEALER for alleged interference through the drive was not allowed.
