BOOGIE RED race back to the drive, was steered wide in the lane, responded to a vigorous hand ride but was late. SUNSHINE SUZIE vied outside SHE'SATHINK'N to before the drive, got clear, was headed by CIELO DOVE and then gave way grudgingly. MALAWI close up, had no response. PROFESSIONAL CAT raced inside and lacked the needed finish. CARSON'S TWINKLE raced inside and had no response. SMOKING KITTY raced wide. JUST DELICIOUS moved in early and

was outrun. MISS SILVER PISTOL raced wide. NO NET showed little. ROONIKI showed early foot, then dropped back. SHE'SATHINK'N vied for the lead to mid turn, then stopped.
