PRINCESS IRIS veered out into OBTRUSIVE after the break, was straightened, hustled clear around the turn and proved best under strong handling. PRINCESS RUBY saved ground from early on, advanced and while no match for the winner was best of the rest. IKE AND FANNIE bothered at the break, was unhurried while outrun, rallied wide around the second turn and then could make little impact. MISS RIDDLER settled, lacked a serious rally. MS LOMOND'S DANCER trailed until before the drive and then improved position. SUBLIME TIME forced wide entering the first turn, recovered, moved up down the backstretch and faded. JAELOON'S JOY checked from between foes entering the first turn, saved ground and was outrun. ILE DE LINDA steered out to avoid GENNIE'S CHALLENGE entering the first turn, bothered outer rivals and was outrun. OBTRUSIVE bothered by PRINCESS IRIS at the break, recovered and was outrun. SUPER SEXY forwardly placed for six furlongs, tired. GENNIE'S CHALLENGE lugged out entering the first turn and was outrun. HEY LITTLE LADY squeezed between foes entering the turn, was outrun.
