PIE I'D raced forwardly and had no rally. SMILE N' EMILY raced close up while three wide and faded. CAPRICIOUSNESS unhurried early, had no rally. X HOSS had no speed and was not a threat. SWEET LILLIAN saved ground. PHIL'S REVENGE stalked the leader down the backstretch, his rider lost his iron entering the turn, could not keep up and dropped back. DAWN'S DELITE was always back. DIVINE EVIL was outrun. WISE MERRY showed little. LADY VAMP had no speed and was not a threat.
