CANDID GLEN between foes early, gained the rail before the first turn, continued inside while unhurried, moved up around the second turn, eased out to take over outside DELLA FRANCESCA before mid stretch, gained the edge and proved best under a drive. ROUVRES (FR) reserved along the inside early, eased outside for the run down the backstretch, continued outside while advancing around the second turn, swung out six wide turning for home, loomed boldly a furlong out but was out kicked to the wire. FREEFOURINTERNET reserved early, raced inside around the second turn, eased out for the drive, angled back to the rail, finished big but missed. SEINNE (CHI) trailed until the drive, swung out ten wide for the drive and was gaining late. MYSTERY GIVER inside early, moved out to race wide down the backstretch, continued outside to circle foes nearing the drive, loomed a threat and then weakened. REQUETE (GB) raced close up while three wide until upper stretch and tired. RUN TO VICTORY devoid speed, split foes but was no real threat. EVEN THE SCORE close up, faded. CENTURY CITY (IRE) forced the pace until before the drive and stopped. DELLA FRANCESCA crossed to the rail, set the pace until turning for home and emptied out. ORCHARD PARK was always outrun.
