Footnotes

LOUISIANA DE SOTO chased the pace, raced two to three wide on the turn, made a bid passing the five-sixteenths pole, came four wide into the stretch, inched clear near the three-sixteenths pole and drew away under steady urging. ROSS LAD was reluctant to load, brushed with a rival at the start, was urged along while off the pace, raced three then four wide on the turn, came five wide into the stretch and secured the place while no match for the winner. PRINCE ROBEAR showed good speed and set the pace, was challenged near the five-sixteenths pole, battled into upper stretch and weakened while clear for the show. SAIL ON CAPOTE chased the pace, raced two then three wide on the turn, came four wide into the stretch and tired. PUTTHEHURTONEM was off several lengths slow, raced well back in the field, went three wide on the turn, moved out in upper stretch and improved position. WHOA WHAM BY LUCK was ridden along on the outside, raced four wide on the turn and came up empty. PORT ORLEANS was fractious in the gate, raced off the pace while urged along, saved ground on the turn and failed to threaten. DAVE'S BERTRANDOS was taken up at the start, raced three to four wide on the turn and was no factor. MY BLACK CAT brushed with a rival at the start, was ridden along near the back and failed to respond. CANE CUTTER was urged along while off the pace, raced off the rail on the turn and also failed to respond. PUCK'S BOY saved ground on the turn and was outrun.
