ARCHIE WILL'M was hustled from the start, disputed the pace, dropped back early on the turn, chased KLOZER into the stretch, moved out while under the whip, pursued the aforementioned rival into the final furlong, drifted out a bit near the sixteenth-pole, took the lead at that marker and proved best under strong urging. DIXIE FORTY FIVE raced well back in the field, went four then five wide on the turn, rallied into the final furlong and closed strongly but was too late. KLOZER moved up after the start, disputed the pace, edged clear early on the turn, remained clear into the final furlong, lost the lead at the sixteenth-pole and was outfinished while able to hold the show. PORT REPUBLIC dropped back while urged along, swung five wide into the stretch and improved position. TIGER RUN was reluctant to load, raced on the outside while ridden along, went four to five wide on the turn and failed to threaten. SHELBY SCOTT settled off the pace then dropped back and was no factor. LAFITTE chased the pace on the outside, raced four then three wide on the turn and tired. HOLLYWOOD HUGHES was ridden along while off the pace, raced three wide on the turn and was no factor. PUDDIN' DINK was ridden along while off the pace, went three to four wide on the turn and failed to respond. ANHYDRITE chased the pace, raced three then two wide on the turn and weakened. PONTCHARTRAIN raced at the rear of the field and showed little. BE A CHEROKEE showed speed then chased the pace, dropped back

leaving the backstretch, raced inside on the turn and came up empty.
