### Footnotes

EASY JAZZ chased the pace, moved in near the half-mile pole, espied an inside opening midway through the turn, was taken up when SWIFTY UNEAUX drifted closer to the rail, regained momentum after a few strides, swung four wide at the top of the stretch, rallied quickly to the lead and drew away under strong handling. OUTTA TUNE was ridden along while off the pace, raced off the rail early on the turn, shifted four wide near the five-sixteenths pole, came five wide into the stretch, moved a bit further to the outside and narrowly earned the place while no match for the winner. HARD CASE pressed the pace, vied three wide on the turn, battled past the three-sixteenths pole and tired then was caught for the place. MACABE'S GOLD dropped back just after the start, raced off the rail early on the turn then dropped to the inside, moved back off the rail at the top of the stretch and improved position while just missing the minor awards. HUDSON'S CREED was forwardly placed on the outside, vied four wide on the turn and weakened. STORM HALF brushed the inside of the gate at the start, was beaten for speed while racing on the inside, came off the rail near the five-sixteenths pole, swung six wide into the stretch, angled further to the outside and failed to rally. SWIFTY UNEAUX set the pace while off the rail, vied a bit off the inside on the turn, battled into upper stretch then gave way. TIDE RISING was urged along while off the pace, raced three wide on the turn, moved out after straightening for the drive and failed to respond.
