LISA'S FRIENDS bobbed at the start, recovered to set the pace, clear early, soft splits, responded when challenged stretch,dug in while drifting out carrying the runner up out with him. FOLLOWING A STEWARDS' INQUIRY REGARDING THE STRETCH RUN, LISA'S FRIEND WAS DISQUALIFIED AND PLACED SECOND. CORWYN'S SHARK never far back, ranged up outside to challenge turning for home, dueled to the wire with the winner while being carried out in the late going. DREAM TOWN void of early foot, rallied outside, no match for the top two. EXCELL WITH ELLE fell back to trail into the lane, improved position stretch. GOODBYE BEAUTIFUL closest to the leader, had little left for the stretch run. HOLLAND POLLAND lacked a late bid. RURAL RED faded after five furlongs.
