**Footnotes**

DEFENDER'S WORD forwardly placed, continued to stalk the leader while in the three path, challenged from the outside when straightened for home, drove clear. SOUND THE ALARM in the second group early, also came on the outside for the drive, drifted out a bit when straightened for home, up for the place late. ROGUE RAGE asked to clear from the outside, showed the way through the turn and narrowly into the stretch, brushed from both sides three sixteenths out, finished on rail, caught late for the place. MAUKADOODLEDOO forwardly placed, challenged the leader from the inside entering the stretch, brushed with that foe, faltered. SO STATELY steadied along the inside into the turn, advanced while off the rail into the lane, lacked a closing kick. RUSH RED BIRD RUSH raced three wide four wide into the lane, improved slightly. RED CAT BAYOU saved ground to no avail. WAYFARER near the back, passed tiring foes. CAJUN MOMENT five wide late in the turn, failed to rally. CONSISTENT THREAT was outrun. BENEDICTO off slow, trailed much of the way. EVANS RUBY steadily faded four wide.
