B'WANAGOLDMINE within striking distance while in hand and inside, continued to be patiently handled second turn, moved out three wide for the drive, bid, drove well clear. U APPEAL TO ME pressured the early leader, vied between foes into the lane, no match for the winner the final furlong, well clear of the rest. NOCKNONHEAVENSGATE broke on top, cleared toward the inside, pace, lasted for the show. FUTURE DIRECTION raced forwardly and on the outside first turn, moved up to challenge three wide late in the second bend, fanned four wide into the stretch, weakened. SPEIGHTSTOWN SON trailed much of the way, never dangerous. STRIKING HIGHT firmly rated off the pace in the early going, had little left.
