WEIGHT: Three Year Olds - 119 lbs. Older - 124 lbs. Fillies and Mares allowed 5 lbs. Non-winners of three races for an allowance purse or for a starter or claiming price of \$10,000 or greater since January 1, 2010, allowed 2 lbs.; of two races for an allowance purse or for a starter or claiming price of \$8,000 or greater since January 1, 2010, allowed 4 lbs.; of a race for an allowance purse or for a starter or claiming price of \$8,000 or greater since January 1, 2010, allowed 6 lbs. Maximum field size in each of the Claiming Crown races will be 14 starters. The 14 starters for that race will be selected by point total in accord with the point system set forth by Claiming Crown Ltd. In the event that two or more horses have the same point totals for a pre-entered race, selection priority will be determined by the tie breaker rules set forth by the Claiming Crown Ltd. Footnotes

ATTHEBUZZER was well placed behind the dueling leaders, came under urging while three then four wide on the turn, rallied on the outside in upper stretch, closed well to get the lead near the sixteenth-pole then moved clear under strong urging. BOMBAST dueled on the inside, shook clear in upper stretch, was headed near the sixteenth-pole then outfinished while able to hold the place. PLASMA BEAM settled on the outside, raced four wide on the turn, dropped to three wide near the five-sixteenths pole, came one off the rail into the stretch and finished willingly for the show. SHERLOCK settled off the pace, went three wide on the turn, was in tight when PLASMA BEAM came in near the five-sixteenths pole, moved out in upper stretch and failed to rally. SURE SUCCESS settled off the pace, was ridden along while off the rail on the turn, dropped to the rail coming to the quarter-pole and also failed to rally. TIDE RISING settled on the inside, was ridden along while saving ground on the turn and came up empty. EXPECT A FLYER settled on the inside of SHERLOCK, saved ground on the turn, took a bit of an awkward stride near the five-sixteenths pole, angled out in upper stretch and failed to threaten. GENTLEMANSAPPROVAL dueled on the outside, vied into upper stretch and tired. Following the race, the rider of SHERLOCK lodged an objection against PLASMA BEAM for interference near the five-sixteenths pole. After the stewards' review, no change was made to the order of finish.
