### Footnotes

TRACKERMAN allowed to settle, raced four wide around the first turn, was widest down the backstretch, moved up four wide around the second turn, rallied determinedly and prevailed. FIFTY FIVE settled early, raced off the rail down the backstretch, came inside around the second turn, angled out after entering the drive, angled back in and got up for second. DEMETEOR between foes to nearing the drive, moved out and was outfinished. CAPE SAN BLAS unhurried early, rallied around the second turn, surged clear but faltered late. KING OF SPEED forwardly placed off the rail, had no response. GRAPELLI raced wide and closed mildly. SIR RABBIT raced inside and faded. REVIVAL RIDGE moved clear while off the rail early, continued off while opening up down the backstretch, then stopped once overtaken before the drive. CAJUN CONQUEST showed little.
