**Footnotes**

WARREN'S REBEL was urged along while just off the pace, advanced three wide on the turn, made a bid at the quarter-pole, dueled with SUNBEAN while being carried off significantly in the stretch and gamely prevailed. SUNBEAN chased the pace on the outside, raced off the rail on the turn, made a bid near the five-sixteenths pole, dueled with the winner while drifting out badly under persistent left hand urging and was denied. PURE CAJUN moved to the lead, set the pace, vied inside on the turn, was headed at the top of the stretch and weakened. DEADLY TRUTH was urged along while off the pace, raced three wide on the turn and just missed the show. REQUEST A PUCK was urged along on the inside, hesitated while in tight near the half-mile pole then dropped back, came out and bumped RETALIATOR entering the turn and failed to threaten. HOPEFUL NOTION broke out and hit the gate, was urged along on the outside, raced four wide on the turn and failed to respond. RETALIATOR was urged along towards the rear, bumped with REQUEST A PUCK leaving the backstretch, raced three wide on the turn and was no factor. NINTH WARD MAN broke a bit awkwardly, raced well back in the field and never reached contention. PORTER'S PIC SIX raced four wide on the turn and was outrun. CHIEF EXE OFFICER chased the pace, raced off the rail on the turn and faded. SPARKLING BROTHER chased the pace, dropped back while inside on the turn and retreated. COLLIN TIME was ridden along on the outside, raced five wide on the turn and faltered.
