WICKED DEED settled well off the pace, raced off the rail on the turn, came three wide into the stretch, angled out near the three-sixteenths pole, closed fast to get the lead coming to the sixteenth-pole then powered away in an impressive display. REIGNING CATS showed good speed, moved clear nearing the half-mile pole, controlled the tempo while inside on the turn, responded well when asked for her best in upper stretch, held a clear lead into the final furlong but was swallowed up by the winner and proved no match while just able to get the place. ST. JOHN'S RIVER brushed with a rival after the start, was urged along in the middle of the field, raced three to four wide on the turn and lacked the needed response then just missed the place. LOST MY HALO brushed with rivals after the start, showed good speed, chased through the turn and weakened. SOUTHERN MINX bumped with a rival at the start, bumped with SHE'S PICKY near the half-mile pole, lacked room from the three-eighths pole to the five-sixteenths pole, came between rivals near the furlong marker and failed to rally. SHE'S PICKY was carried out at the start, moved up while under some restraint and eager, bumped with SOUTHERN MINX near the half-mile pole, was in tight early on the turn, came under urging at the top of the stretch and failed to respond. PERFECT CHERIE brushed with a rival after the start, showed speed then chased the pace, dropped back while inside on the turn and tired. SHE CAN FLY jostled with a rival after the start, was ridden along towards the rear, went four to five wide on the turn and failed to threaten. ELECTRIC BOOTS bumped with a rival at the start, raced towards the front of the field, chased three wide on the turn, steadied while tiring near the furlong marker and gave way. MESSAGE RECEIVED bumped with a rival at the start then was jostled between foes and checked sharply, raced near the back on the outside, was caught five wide early on the turn then dropped to three wide and was no factor. WIMBLEDON STAR was unruly in the gate, dropped back on the inside while lugging out bit and retreated.
