OVERHEARD settled while off the inside, moved closer late on the backstretch, was roused on the far turn, shifted four wide outside the quarter-pole, gained the lead in upper stretch, drifted out under left hand urging near the furlong marker, moved clear in the process, was straightened by the rider and proved much the best under good handling. MISS CLARK COUNTY tracked the pace on the outside, chased on the far turn, made a bid in upper stretch and proved no match for the winner while able to get the place. INCREDIBLE JOURNEY settled towards the rear, was urged along on the far turn and improved position while up for the show. EDEN PRAIRIE was taken in hand then reserved on the inside, came under urging while continuing to save ground on the far turn and failed to rally. TRULY MARIE went three wide on the first turn, settled on the outside, ranged up while three wide on the far turn, made a bid under a drive in upper stretch, chased the winner into the final furlong and weakened. MY DAUGHTER'S SONG set the clear pace on the inside, lost the lead in upper stretch and gave way. HIT GIRL went four wide on the first turn, settled on the outside, dropped back while four wide on the far turn and failed to respond. SWEET CITIZEN saved ground on the first turn, lagged at the rear, raced near the inside on the far turn and was no factor. (Rail at 25 Feet)
