Z FEME FEME FEME broke alertly then showed good speed, chased the pace on the outside, raced four then three wide on the turn, made a bid inside the quarter-pole, led into the final furlong, drifted in some near the sixteenth-pole, bothered rivals to her inside and prevailed. AUGUST HIGH was well placed on the inside, chased while off the rail on the turn, gained the lead at the top of the stretch, lost the advantage to Z FEME FEME FEME, steadied when that rival drifted in near the sixteenth-pole then finished willingly for the place. SASSYFROMTHEGITGO bumped with a rival at the start, dueled for the lead, moved clear nearing the half-mile pole, controlled the action while inside on the turn, was headed passing the quarter-pole, battled inside into the final furlong, steadied near the sixteenth-pole then weakened while clear for the show. FRANCESCA DEL PORT was reluctant to load, broke out a bit at the start, was ridden along on the outside, chased four to five wide on the turn, came under the whip in upper stretch and tired. MOTOROLA JADE was ridden along near the back, raced inside on the turn, shifted out and bumped with PRETTY LEGS at the top of the stretch and improved position. ROSE LIPS bumped with a rival at the start, was urged along while off the pace, raced three wide on the turn and failed to rally. TRULY JUDY was ridden along on the outside, raced four then five wide on the turn and also failed to rally. GULF QUEEN dueled for early lead while on the outside, dropped back near the

half-mile pole, went two to three wide on the turn and tired. PRETTY LEGS lacked speed while ridden along, raced three wide on the turn, was bumped by MOTOROLA JANE at the top of the stretch and failed to threaten. SWEET LOUELLEN was ridden along while off the pace, raced off the rail on the turn and failed to respond. Following a stewards' inquiry, Z FEME FEME FEME was disqualified from first and placed third for interference near the sixteenth-pole.
