BELEND prominently placed four wide, loomed four wide for the drive, then while no match for the winner, saved second. KAT'S COURT restrained behind the leaders, moved in nearing the turn, angled out after entering the drive and was gaining late. MY FRIEND TOLD crossed to the inside before the turn, was angled out turning for home and closed late. CUBERA vied for the lead to the drive, then faltered. NOWANDFOREVERMORE lunged at the break, then improved position wide. ELYNN'S VOLARE was never dangerous. SPRIGHTLY STAR vied for the lead from the inside until nearing the drive, then gave way. HAWAIIAN CHOICE raced inside too no avail. CHATTING BANDIT within striking distance, faded in the drive.
