Footnotes

FOR YOU REppo back early, came four wide around the second turn, rallied outside and drove clear late. INTI (URU) unhurried, came four wide around the second, angled in to split foes in the lane and got up for second. PRESENTS FOR BERTI raced inside much of the trip, bid inside the furlong grounds, then had no final kick. JIMANATOR raced inside and made a late gain. NINTH CLIENT stalked BK'S CLEARANCEISLE from early on, bid around the turn, then faltered late. WEEKEND PASS forwardly placed three wide, bid in upper stretch, gained the edge, then failed to sustain his bid. TERRYHOWIEANDJIMMY reserved early, came five wide around the second turn, then had no late kick. LONESUM GEORGE forwardly placed to the drive, faded. BK'S CLEARANCEISLE set the pace to the drive, was headed and stopped. SUNSET LIMITED crossed to the inside going to the first turn, was forwardly placed for a half and then retreated.
