### Footnotes

BRILLIANTBRILLIANT raced three wide on the first turn, was rated just off the pace, ranged up while three to four wide on the far turn, made a bid and was asked at the top of the stretch, was put to the whip near the furlong marker and inched clear under right hand urging. GUILTY PLEA raced three wide on the first turn, prompted the pace on the outside, vied two to three wide on the far turn, came under right hand urging in upper stretch, battled into the final furlong and was outfinished while able to secure the place. SEE THE STREAK broke in a tad at the start, was in tight against the rail nearing the first turn, raced just off the pace while under restraint and saving ground, moved out on the far turn, shifted five wide at the top of the stretch, was asked for his best and lacked the needed kick while able to garner the show. SHAPE raced off the rail on the first turn, settled off the pace, was hard ridden while three to four wide on the far turn and failed to rally. SOUTHERN SAINT broke in a tad, moved to the early lead, set the pace while a bit off the rail, vied inside of GUILTY PLEA on the far turn and gave way. SA HOSS lagged at the rear of the field, was roused while off the rail on the far turn and failed to respond. STORMOFTHESOUTH dropped to the rail before the first turn, settled on the inside, was urged along while continuing to save ground on the far turn and failed to threaten.
