Footnotes

LYDGATE'S PROOF brushed with a rival at the start, moved to the lead, set the pace on the inside, responded well when set down in upper stretch and held under steady urging. REED'S STEED tracked the pace on the outside, chased on the turn, came under a drive in upper stretch, pursued the winner into the final furlong and was second best. GLAD TRIBUTE brushed with a rival at the start, raced well off the pace, moved off the inside on the turn, came under the whip in upper stretch and finished willingly for the show. ROYAL DEBUT was urged along on the outside, chased three wide on the turn and tired. FABULOUS FAB was urged along on the outside, raced four wide early on the turn, dropped to one off the rail near the three-eighths pole and failed to respond. RULE THE THUNDER was reserved off the pace, went two then three wide early on the turn, moved to four wide near the five-sixteenths pole, drifted five wide into the stretch and failed to rally. CROWN HIM WINNER was urged along while just off the pace, raced inside on the turn and came up empty. CAJUN HAWK settled while under some urging, raced three wide on the turn and failed to respond. MILD MANNERED MAN was bumped at the start then forced hard into HEAVEN LEE SPRITE and steadied, moved up some while urged along on the outside, raced four wide on the turn and failed to threaten. BACK SEAT AFFAIR came out at the start and bumped with MILD MANNERED MAN then was corrected, dropped well behind the field, raced two then three wide on the turn and was no factor. HEAVEN LEE SPRITE was bumped very hard at the start then veered out and was pulled up but walked off.
