EVERY WAY brushed with a rival at the start, was carried six wide early on the first turn then dropped to four wide, floated wider onto the backstretch, was well placed behind the leading duo, made a bid while three wide on the far turn, battled gamely in the stretch and narrowly prevailed under strong urging. FLASHY GAL went two to three wide on the first turn, settled between horses on the backstretch, moved closer near the seven-sixteenths pole, advanced four wide on the far turn, chased in upper stretch, found her best stride while in the clear in the final furlong and gained late but missed. PROPELLERONEWAY was taken back in the early going, went five wide on the first turn, settled on the outside, moved closer late on the backstretch, circled six wide on the far turn, made a bid at the quarter-pole, battled with EVERY WAY, drifted in near the sixteenth-pole and just missed. HURRICANE KRYSTAL brushed with a rival at the start, went four wide on the first turn, settled on the outside, moved closer near the seven-sixteenths pole, was roused while four wide on the far turn, advanced between rivals into the stretch, chased under a drive and weakened. STREET OF GOLD broke in at the start, settled near the inside, came under a drive in upper stretch and failed to rally. A P ZAPPER bobbled at the start, went six wide early on the first turn, dropped to three wide late on that bend, lagged at the rear, went three wide on the far turn, came four wide into the stretch and failed to threaten. MISS CLARK COUNTY went to the front, lugged out entering the first turn, raced four wide early on that bend then dropped to one off the rail, drifted out entering the backstretch, set the pace, was swallowed up near the five-sixteenths pole and tired. CECILEABRATION was carried five wide into the first turn, dropped to three wide late on that bend, was floated out onto the backstretch, disputed the pace on the outside, dropped out nearing the quarter-pole and weakened.
