NEW YORK STYLE assumed the lead, showed the way and then was kept to the whip. WABASH RIVER was well placed, angled out in the lane and finished with good energy. ZEPPIES SHADOW was well placed five wide on the turn, continued wide and hung. LION ON THE RUN tracked the winner along the three path and weakened. ANOTHER GULCH bobbled at the start, three path on the turn and weakened. DIVORCED DECISION five wide on the turn, wide in the lane and weakened. BRAZEN ACTION in tight between at the three-eighths pole, checked and weakened. AGRIGENTO saved ground, was outrun. Claims of foul was lodged by the rider of BRAZEN ACTION against WABASH RIVER and ZEPPIES SHADOW for alleged interference at the three-eighths pole, was not allowed.
