PAY THE JUDGE was unhurried along the rail, eased out for the drive but was no match for the top two. ALMOST A FOOLS DAY forced the issue, chased and weakened. SPAT hit the gate at the start, four path on the turn and weakened. PIDSPRIDE three path on the turn and tired.
