TELL ME FIRST broke well, vied for the lead along the rail, shook free some in upper stretch, was hooked in midstretch, responded to the task and drove clear. TOO TOUGH JAKE broke slow spotting the field a length, saved ground on the turn, eased out, collared the winner in midstretch but could not match strides. CAJUN JET vied for the lead along the three path and weakened. GRANBY BOY was unhurried along the three path into the lane, angled wide for the drive and then lacked a solid bid. BUCKRIDGE BAILEY well placed along the two path on the bend and weakened. WINGNUT four path into the lane and hung.
