**Footnotes**

HI POPPY tracked along the rail, dueled after a half mile, took charge on the last turn and then drifted out to the line while well clear. RUNLIKEACHAMPION was well placed, gained along the four path on the last turn, chased, altered in for room in deep stretch while clearly best of the rest. FEROCIOUS WON four path on the turns, gained some in the lane and hung. DONE THAT two path on the turns, entered the lane along the three path and then failed to take part. LEGAL TENDORA was well placed, tracked along the three path on the last turn and weakened. CALL TIGER was unprepared for the start, broke slow, saved ground, weakened in the lane and then was declared a non-starter. CHURCHONSUNDAY set the pace off the rail, dueled after a half mile and gave way. A stewards inquiry was posted concerning CALL TIGER at the start, resulted in declaring CALL TIGER a non-starter.
