TAKE A WALK broke sluggishly, unhurried, gained along the two path on the last turn, angled out and rallied for the win. POWHATAN COUNTY vied for the lead along the rail, battled inside in the lane, took the advantage and then held on stubbornly. PURA P T was unhurried early, gained along the three path on the last turn, angled out and finished with interest. JEMARU vied for the lead along the two path on the turns, battled between in midstretch and weakened. SUSPICIOUS U was well placed, gained along the three path on the last turn to challenge three across at the top of the lane, battled outside and weakened. SEA FIGHTER lagged back, saved ground on the turns and then failed to take part.
