C T CHIMES was unhurried, gained along the three path, angled out in the lane, asked, rallied to take command and then drew off under the whip for the win. RULE SEVENTY SIX was well placed, tracked along the four path, gained, battled but was no match for the winner. GOOD LAW slammed with ROCKET BOOSTER at the start, unhurried, three path on the turn and then closed well for a share. CINNER DAVE was unhurried, three path on the turn, angled out and finished with interest. PYGMALION vied for the lead early, took charge on the bend, was hooked and weakened. PINKY FREUD forced the issue early, tracked and tired. ROCKET BOOSTER slammed from both sides at the start, checked and then was outrun. MAJESTIC KARAKORUM four path on the turn and tired. SUGAR SLAM slammed with ROCKET BOOSTER at the start and then was outrun. BAIT AND SWITCH saved ground, was done early.
