POINT ME TO IT bobbled at the start, tracked up the backstretch, three path on the last turn, chased to no avail but finished best of the rest. SOFT EXPRESSION was unhurried up the backstretch, three path on the last turn and then was along for a share. ACCREDITING unhurried while five wide up the backstretch and then lacked a rally. PLEASURE FOR ME tracked up the backstretch, three path on the last turn and tired. SCENE N HEARD lagged back and showed little.
