CREA'S LAW was well placed five wide up the backstretch, gained along the three path to challenge four across at the top of the lane, battled to the line with MUSTER UP and under pressure proved best. MUSTER UP broke well, set the pace along the rail, pressed after a half mile, battled the winner in the lane and just missed. WARRIOR FROM ABOVE never far back along the rail, continued inside to challenge into the lane and hung. RAECINJASIN was well placed along the three path, two path on the last turn, eased out to the three path into the lane, appeared to have a chance and weakened. GREAT BEAR four wide into the backstretch, trailed along the two path, three path on the last turn, angled out and then failed to gain. JUST A MINUTE stalked, dueled after a half mile, between foes into the lane and tired.
