EASY SPUR lagged back, three path on the last turn, gained, altered out in midstretch for room and rallied for the win. DAVID IS MAD was well placed, tracked along the three path on the last turn, challenged and finished gamely. DEWANNA BRUSHON ME stalked, took command after a half mile, showed the way and then weakened late. JACKSON CROSSING lagged back, three path on the last turn and then lacked a rally. TIME PIECE four path on the first turn, two path on the last turn and weakened. FACE IN THE MIRROR well placed, four path on the last turn and weakened. SUNNY BOY 'N BEN E set the pace early, was hooked, tracked and weakened. NORMAN'S GOOD BOY three path on the first turn, in tight between foes leaving the three-quarter pole, took up sharply, saved ground on the last turn and tired.
