FOLLY DOLLAR assumed command, set the pace off the rail, opened up some nearing the eighth pole and then was all out for the win. DOUBLE THE DEBT was well placed off the rail, angled out leaving the backstretch, entered the lane five wide, responded leaving the eighth pole and rallied. BELONGS TO MONY was unhurried along the four path leaving the backstretch, angled to the rail into the lane and closed well. J AND B'S NU IMAGE was well placed along the four path, chased the winner into the lane and then weakened. ALLEY BALL lagged back along the three path and then angled well out in the strip for the drive. DARLING BOBI was close up along the three path to the lane and faded. FLASHING LIL was unhurried, gained some while six wide on the turn and then tired. DEVILISH EYEZ checked at the start, saved ground and then was outrun.
