SHUFFLING MADDNES was unhurried off the rail, gained on the last turn, angled out five wide into the lane, lodged a bid outside and finished with good energy to clearly best the rest. FIRE ONE UP in hand while saving ground up the backstretch, asked into the lane, lodged a bid and then could not sustain the drive. HE'S A LUMBERJACK lagged back along the four path, three path on the last turn, angled out and then lacked the late needed response. SARATOGA JET vied for the lead from between foes, chased on the last turn and weakened. INDIAN HAWKE contested the lead while three abreast up the backstretch, chased on the last turn and weakened. NEW TESTAMENT five wide up the backstretch, continued wide on the last turn and weakened. JUDGE TOMMY D. was outrun.
