WINLOC'S JOHN LEE vied for the lead along the four path leaving the backstretch, angled to the three path into the lane, was hooked in upper stretch by MERCER CROSSING, disposed of that one and was under the whip for the win. CRIMINAL JUSTICE lagged far back, two path on the turn, angled out and rallied. MERCER CROSSING was well placed along the two path, slipped inside to reach the winner in gear in upper stretch and then hung in the late stages. JESSIE TOWTRUCK lagged far back, saved ground, eased out and then failed to take part. ROCKSTAR ONE O ONE vied for the lead five wide with the winner leaving the backstretch, four path into the lane and gave way.
