Footnotes

PRO'S PAL broke on top, saved ground while setting the pace, widened in the lane and then was kept to the whip for a lengthy score. TOO TOUGH PETE took back at the start, tracked along the two path while to the inside of ESTIMATOR on the turn, stayed with that one in the lane and then finished well to best ESTIMATOR and the rest. ESTIMATOR was well placed along the three path outside of TOO TOUGH PETE on the turn, stayed to the outside of that one in midstretch but could match strides and then finished well enough to secure a share. DAHLGREN CHAPEL was unhurried along the two path on the turn, angled out in the lane and then could not gain. YOU'LL REMEMBER ME trailed along the two path leaving the backstretch, three path on the turn while still trailing and then continued outside while never getting involved.
